Resolution 958 (WRC-15)

resolves

to complete studies on the topics identified in this resolution and its annex, invites ITU-R

as a matter of urgency, to complete the studies called for in this resolution, *instructs the Director of the Radiocommunication Bureau* to report on these studies under agenda item 9.1 of WRC-19, as appropriate, based on the results of studies.

Urgent studies required in preparation for WRC-19

2) Studies to examine:

a) whether there is a need for possible additional measures in order to limit uplink transmissions of terminals to those authorized terminals in accordance with No. **18.1**;

b) the possible methods that will assist administrations in managing the unauthorized operation of earth station terminals deployed within its territory, as a tool to guide their national spectrum management programme, in accordance with Resolution ITU-R 64 (RA-15)



Resolution ITU-R 64 (RA-15)

Guidelines for the management of unauthorized operation of earth station terminals

resolves to invite ITU-R study groups concerned

1 to conduct studies to examine whether there is a need for possible additional measures in order to limit uplink transmissions of terminals to those terminals authorized in accordance with No. 18.1; 2 to study the possible methods that will assist administrations in managing the unauthorized operation of earth station terminals deployed within their territory, as a tool to guide their national spectrum-management programme.

No. 18.1 of the Radio Regulations

18.1 § 1 1) No transmitting station may be established or operated by a private person or by any enterprise without a licence issued in an appropriate form and in conformity with the provisions of these Regulations by or on behalf of the government of the country to which the station in question is subject (however, see Nos. **18.2**, **18.8** and **18.11**).

Background & Issue under study

- FSS systems designed to meet the demand for global communication services are characterized by flexible, rapid and ubiquitous deployment of large numbers of cost-optimized earth stations employing small antennas and having common technical characteristics.
- The issue under study is ubiquitous uplink transmissions from satellite terminals not adhering to international regulations or national service rules. Unauthorized ubiquitous uplink satellite transmissions may cause interference to legitimate users as well as raise other difficulties for ADM spectrum managers.

 these unauthorized ubiquitous uplink satellite terminals and,
 if they were operating without authorization, how to locate
 them so action could be taken by the administration?
